BY-LAW NO. 16-107

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 4 (Yield signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following items, namely:

"Bookjans Drive	Westbound	John Frederick Drive
John Frederick Drive	Northbound and Southbound	Bookjans Drive"

2. Schedule 4 (Yield signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "C" (Flamborough) thereof the following items, namely:

"Cole Street	Northbound and Southbound	Nisbet Boulevard
Nisbet Boulevard	Eastbound and Westbound	Cole Street"

3. Schedule 5 (Stop signs) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following items, namely:

4. Schedule 5 (Stop signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following items, namely:

"Dodman Crescent (North leg)	Eastbound	John Frederick Drive
Dodman Crescent (South leg)	Eastbound	John Frederick Drive
Martineau Place	Westbound	John Frederick Drive"

And by adding to Section "C" (Flamborough) thereof the following items, namely;

"Centre Road	Northbound and Southbound	10 th Concession Road East
10 th Concession Road East	Eastbound and Westbound	Centre Road

And by adding to Section "E" (Hamilton) thereof the following items, namely;

"Beaucourt Place	Westbound	Lower Horning Road
Beaucourt Road	Eastbound	Lower Horning Road
Butty Place	Westbound	Lower Horning Road
Jackson Street East	Eastbound and Westbound	Ferguson Avenue South
