BY-LAW NO. 16-175

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Bendamere	North	Delmar to Briarwood	1 hr	8 am – 6 pm	Mon – Fri
Bendamere	South	Columbia (west leg) to Briarwood	1 hr	8 am - 6 pm	Mon – Fri"

and by adding to Section "E" thereof the following items, namely:

"Bendamere	North	Delmar to west intersection with Briarwood	1 hr	8 am – 6pm	Mon – Fri
Bendamere	South	West intersection with Columbia to west intersection with Briarwood	1 hr	8 am – 6 pm	Mon – Fri"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following item, namely:

"Homestead West from 34.3m south of Airport to Anytime" 42.4m southerly

and by deleting from Section "E" thereof the following item, namely:

"Rebecca South Hughson to John 7:00 a.m. to 6:00 p.m."

Monday to Friday

and by adding to Section "E" thereof the following items, namely:

"Rebecca South Hughson to James 7:00 a.m. to 6:00 p.m. Monday to Friday

from 40.2m north of the Sundown East & Anytime" South

extended north curb line of Skyview to 23.9m northerly and easterly along the curbline

and by adding to Section "F" thereof the following items, namely:

"Echovallev West & from 181.m north of **Anytime** South Stockbridge to 20.7m northerly and westerly along the curbline Echovalley East & from 57.8m south of Winslow Anytime North to 25.1m southerly and easterly along the curbline Maple North Millen to Southmeadow **Anytime Thornbury** West & from 42m north of Westbank to Anytime South 25.9m northerly and northwesterly along the west curbline Westbank West & from 109m north of the Anytime extended north curb line of South Stockbridge to 21m northerly

and westerly along the curbline

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Tisdale West from 22.3m south of Wilson to 6m Anytime" southerly

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "F" thereof the following item, namely:

"Ridge Both from 234m west of First Road Anytime" East to 494m westerly

To Amend By-law No. 01-218, as amended, Being a By-law to Regulate On-Street Parking
