## **Do Solemnly Declare That:**

- 1. I am qualified pursuant to the Municipal Elections Act, 1996 and the Education Act to be elected to and to hold the above noted office.
- 2. Without limiting the generality of paragraph 1, on the day the Nomination Paper is filed I am:
  - a resident of the area of jurisdiction of the School Board, •
  - a Canadian citizen, and
  - at least eighteen years of age. •
- 3. I am gualified under the Education Act to vote for members of the School Board to which I am seeking office.
- 4. I am not ineligible or disqualified under the Municipal Elections Act, 1996, the Education Act, or any other Act to be elected to or hold the above-mentioned office.
- Without limiting the generality of paragraph 4, 5.
  - I am not an employee of the School Board or if I am an employee of the School Board, I ٠ am on an unpaid leave of absence as provided for by section 219 of the Education Act and section 30 of the Municipal Elections Act, 1996.

- I am not a clerk or treasurer or deputy-clerk or deputy treasurer of any municipality within the area of jurisdiction of the School Board or if I am such a person, I am on an unpaid leave of absence as provided for by section 219 of the *Education Act* and section 30 of the *Municipal Elections Act*, 1996.
- I am not a member of the Assembly as provided in the *Legislative Assembly Act* or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the City of Hamilton prior to 42:00 p.m. on nomination day, August 19, 2022. I understand that the Clerk of the City of Hamilton will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.
- I am not a member of the Executive Council of Ontario or a federal Minister of the Crown.
- I am not a person who was convicted of a corrupt practice under the *Municipal Elections Act, 1996* or of an offence under the *Criminal Code*, in connection with an act or omission that relates to a municipal election unless at least two regular elections have occurred since the election in respect of which I was convicted.
- I am not ineligible from being elected to or holding office by reason of any violations of the election campaign financial requirements, violations for not filing the financial statement or any other violations pursuant to section 88.23 of the *Municipal Elections Act, 1996*.
- 6. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996.*
- 7. Without limiting the generality of paragraph 6,
  - I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
  - I am not a corporation.
  - I am not a person acting as executor or trustee or in any other representative capacity, except as a voting proxy in accordance with section 44 of the Municipal Elections Act."
  - I am not prohibited because of a conviction of a corrupt practice described in subsection 90(3) of the *Municipal Elections Act, 1996*

**AND** I make this solemn Declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the *Canada Evidence Act*.
