EVALUATION PROCESS

- Applications are assessed based on the assessment criteria specific to each program area and funding stream.
- A minimum of 3 assessors will review and score out of 100.

Final score 80 or above

Excellent Application

Final score between 60 & 80

Good/Fair Application Failed

Final Score below 60

Application



- Funding amounts are dependent on the available budget of the City Enrichment Fund as well as the amount allocated in each program area.

Community Services - Objective

To invest in both **established** and **emerging** community programs that meet identified community needs, build community capacity, and support the new City of Hamilton's strategic funding priorities 2016-2025.

Community Services – Specific Eligibility Criteria

- Criteria for both **Established and Emerging Needs**
- Not-for-profit organizations – unincorporated groups with not-for-profit goals and governance structure are not eligible under the Community Services Stream
- Organizations with a charitable number
- Programs must provide service to residents of the City of Hamilton. Programs that operate in Hamilton, but service clients who reside outside Hamilton are not eligible.
- Applicants must operate year-round and offer programs that are open to the public and publicized city wide.

Community Services – Who is NOT eligible to apply

Both Established and Emerging Needs

- For-profit organizations and ventures
- Religious activities
- Religious organizations except in cases where the applicant demonstrates clear boundaries between the religious activities and budget of the program requesting a grant.
- Public agency
- Political parties
- Hospitals
- Foundations

Community Services – Who is NOT eligible to apply – Both Established and Emerging Needs

- Funding bodies or organizations that act in the capacity of a funding agency that make financial allocations or contributions to other groups such as service clubs, private and non-profit charitable foundations or for profit charitable foundations.
- Fundraising activities
- Organizations whose activities are deemed to come under the jurisdiction of other levels, divisions, departments or agencies of the City or other governments, i.e. school boards, post-secondary institutions, social service organizations, hospitals, business improvement associations etc.

Community Services – Which Stream?

- Your program was approved for funding from the City Enrichment Fund as a returning program within one of the approved funding priority categories (A-G)
- Categories A-G includes the following streams: A – No One is Hungry/Without Shelter, B – Everyone is Safe from Violence, C- Every Child & Family Thrives, D – No Youth are Left Behind, E – Everyone Can Age in Place, F – Community Capacity Grows, G – Everyone has Someone to Talk to.



Established Programs Stream A-G

- You have never applied to the City Enrichment before
- You applied to the Emerging Needs stream in the previous grant year and was awarded funding
- You applied to the Emerging Needs stream in the previous grant year, but were not awarded any funding
- You have consistently applied to the emerging stream category but were **NOT** specifically notified by the program manager to apply to an alternate stream for the upcoming grant cycle



Emerging Needs Funding

Community Services – Established Stream Objective

- To provide funding stability to established community programs with identified funding priorities.
- Applicants will apply through the funding streams A-G identified on the City Enrichment Fund online platform.
- All new requests for funding (whether your program is new or not) must apply through the Emerging Needs stream.

Community Services – Emerging Needs Stream Objective

- To foster community programs that identify new emerging community needs, underserved target groups, areas, or service delivery innovation.
- Due to the dynamic nature of funds in the emerging needs category, funding will be allocated based on scores in each granting year.
- Applicants approved for funding under emerging needs in a previous year may apply to emerging needs the following year, but the application will not be prioritized over other applications.

BEFORE YOU APPLY

HAVE THE FOLLOWING INFORMATION READY:

- Program/Project Name
- Select Program Area & Stream
- Gather applicant E-mail Address (notification letters will be sent to this address regarding outcome of the grant application)
- Organization Name & Legal Name (if different)
- Organization and Project/Program Descriptions & Details
- Create Program Budget

HOW TO APPLY

1. Review the CEF General Fund Guidelines (available online)
2. Determine Program and Funding Stream
3. Review Stream Specific Guidelines and Eligibility
4. Gather [Program Budget Information](#)
5. Create an account (Select 'individual') or login if you already have one
6. Contact your Program Manager with any questions
7. Submit before the November 2, 2022 deadline

 - Information on organizational policies
 - Outcome measures
 - Audited statements
 - Locate other items required as attachments

 - Internet Explorer 9.0 and above
 - Microsoft Edge
 - Firefox 4.0 and above
 - Safari 5.0 and above
 - Chrome 4.0 and above
- Please note application will not currently run on the Microsoft Pocket PC.
- Applicants out of country will not be able to access the application form on-line for security safety.
- If adding collaborators, do they have the appropriate technology?
- Save your online application often
- Try not to wait until the due date to submit to avoid CEF system capacity issues
