On September 30, 2021 the City of Hamilton (City) requested a 14-month extension under Item #6 of the Ministry of Environment, Conservation and Parks (MECP) Director's Order No.1-PE3L3 (Order) which imposed a deadline for the completion of the approved Chedoke Creek Workplan (Targeted Dredge) of October 31, 2021.

The formal request to extend the deadline was made after reviewing and progressing through the permitting and approvals process which included engagement and consultation with the following agencies.

- Hamilton Conservation Authority
- Ministry of Transportation
- Ministry of Northern Development, Mines, Natural Resources and Forestry
- Ministry of the Environment, Conservation and Parks
- Ministry of Heritage, Sport, Tourism and Culture Industries
- Transport Canada,

- Impact Assessment Agency of Canada,
- Royal Botanical Gardens
- Indigenous Nations and partners including:

Information reviewed included field data collection results, assessment and discussions related to each agency's requirements and associated timelines including in-water construction restrictions.

On October 22, 2021, the MECP Director approved the City's requested deadline extension to December 31, 2022 with all other items in the Order remaining in effect, and unaltered. The City will continue to progress through the permitting and approvals process and will inform the various internal and external stakeholders of this amendment to the Order.

## Re: Extension Request of Item No.6 of Director's Order No.1-PE3L3

I am in receipt of your September 30, 2021 request for an extension of the compliance date specified in Item No. 6 of the Order from October 31, 2021 to December 31, 2022.

I have reviewed your request and supplementary revised schedule, '*Revised Chedoke Creek Targeted Dredge Project Schedule, September 2021*' and have consulted with Ministry staff. Based on my review of the documents provided to support the City's request I understand that after assessing the permit and approval process and the in-water construction restrictions, the targeted dredge portion of the workplan will be completed by December 31, 2022. Having considered your submissions and further to our discussions held on Monday October 18, 2021, I am of the view that the compliance date can be extended.

As such, pursuant to my authority under sections 157.3 of the *Environmental Protection Act,* s.16.4 of the *Ontario Water Resources* Act, and sections 49 and 54 of the *Legislation Act, 2006*, I hereby alter the compliance date in Item No. 6 as requested so that Item No. 6 now reads as follows:

6. By December 31, 2022, complete the approved Chedoke Creek Workplan.

All other Items in the Order remain in effect, and unaltered. This order alters and constitutes part of Director's Order No. 1-PE3L3, issued on December 4, 2020. You may require a hearing before the Ontario Land Tribunal in respect of this amendment to the compliance date in accordance with the EPA and the OWRA.

I encourage you to inform the various stakeholders who are interested in the work that is to be completed pursuant to my Order, of this amendment.
