
The purpose of this Information Update is to provide Council with an update on the status of applications for cannabis retail stores in Hamilton and to respond to recent questions asked by members of Council about the review process for applications.

In late 2019, the Alcohol and Gaming Commission of Ontario (AGCO) was given regulatory authority to allow for open market applications for cannabis retail stores. Beginning in January 2020, cannabis retail store applications were no longer awarded via a lottery process, and instead potential applicants provided intent directly to the AGCO for consideration. Between January 2020, continuing throughout the pandemic until February 5, 2021, the City of Hamilton (City) has received 103 notifications of intent for cannabis retail stores from the AGCO, as outlined in Appendix "A".

The AGCO advises the City of an application for a proposed cannabis retail store intending to operate in the City. Within 15 days, the City is responsible for reviewing each application and providing comments to the AGCO. This requires the City's Cannabis Enforcement Team to rely on Council's *Cannabis Policy Statement*, attached as Appendix "B", to canvass the surrounding neighborhood at the 300m mark and create the necessary heat maps and radial separation assessment(s) taking into account schools, parks, day cares, libraries, community centres, addiction and health centres and other cannabis stores. This information is circulated to the appropriate internal parties, including the Building Department, Public Health, Public Works, Zoning, Parking, Hamilton Police, Hamilton Fire and the Ward Councillor and is used to formalize a response back to the AGCO. A Registrar at the AGCO reviews the City's response prior to issuing a decision to the applicant. There is no public meeting or

opportunity for an appeal hearing. After approval, the City's response is forwarded to the applicant. The applicant then has an opportunity to reply to the concerns brought forth and provide action plans or responses to them.

To date, the City has received 103 notifications of intent to open cannabis retail stores. The City has provided comments of: no objection for 58 notifications; objection for 29 notifications, and 16 notifications are still pending and close for comment at different times during the month.



To date, none of the objections put forth by the City have resulted in the decline of a retail store application.

The City has consistently highlighted concerns regarding location density and clustering of cannabis retails stores as well as the close proximity to schools and parks.

The AGCO issues a cannabis retail store licence to all applicants as long as it does not contravene the "public interest" as defined in section 10 of Ontario Regulation 468/18 of the Cannabis Licence Act. 2018:

- 10. For the purposes of paragraph 5 of subsection 4 (6) of the Act, only the following matters are matters of public interest:
  - 1. Protecting public health and safety.
  - 2. Protecting youth and restricting their access to cannabis.
  - 3. Preventing illicit activities in relation to cannabis.

In September 2020, in response to a Motion of Council, Licensing and By-law Services drafted a memo to the Ministry of Attorney General and local Members of Parliament requesting that the Province consider amending the application process, to consider radial separation from other cannabis locations as another factor of public interest. In early October 2020, the City received comment back from the Ministry of Attorney General that they would - "continue to monitor the evolution of cannabis legalization in the province and its impact on our communities".

Below is a summary of Ward density and attached as Appendix "C" is the current radial heat map, to show density of cannabis retail store applications.

The process to comment to the AGCO on a cannabis retail store application, as well as receiving digital notification of intent, has changed multiple times during this process. Licensing and By-law Services has received comments from the public, expressing concern that the process is difficult to navigate and does not allow for any telephone call-in methods. Seniors and those without regular access to a computer or the internet have voiced opposition that the AGCO process is too complex to utilize.

# City of Hamilton Cannabis Policy Statement

For the purposes of this Policy Statement, a Cannabis Retail Store shall mean a store licensed by the Alcohol and Gaming Commission of Ontario (AGCO).

### 1. Cannabis Retail Stores and Sensitive Activities:


In order to help ensure public health and safety, protect youth and reduce illegal sales, Retail Cannabis Stores should generally not be located within 300 metres of:


- Schools
- Parks and Open Spaces
- Alcohol and Detox Centres
- Day Nurseries/Child Care Centres
- Libraries
- Community Centres
- Mental Health/Addiction Centres


### 2. Cannabis Retail Stores should not be permitted in:

In the interest of public health and safety, Cannabis Retail Stores should not be permitted in the following:

- Areas that already have a high concentration of Cannabis Retail Stores (i.e. the "clustering" of stores should be avoided)
- Locations that have insufficient parking or transit access
- Locations that are in predominantly residential areas
- Attached is a map showing the retail/commercial zones of the municipality and that would be prohibited with a 300 metres radial separation from schools:
