SUBJECT: Updates to Policies

The purpose of this communique is to provide an update required by amended regulations to the Housing Services Act (HSA). Effective July 1, 2023, the Province has amended O. Reg. 367/11 requiring Service Managers to set local income and asset limit rules to determine eligibility for RGI Assistance.

As a part of fulfilling this requirement, several local polices have been updated to align with the Income and Asset limits for RGI assistance, as approved by the Hamilton Emergency and Community Services Committee on February 16, 2023.

Below is a list of revised policies and a summary of the changes to each.
