Re: Monthly Report for the month of October 2023

The Building Division report of building activity for October 2023 is enclosed for your perusal.

In October the Building Division issued 544 building permits valued at \$195.86 million.

For the month, the residential component was the strongest accounting for 79.14% of the month's total and is valued at \$155.00 million. Of the 379 permits in the residential category, 164 permits were issued for new single-family dwellings at a total value of \$56.76 million. Commercial activity accounts for 6.35% or \$12.44 million with 31 permits issued. Industrial activity accounts for 13.02% or \$25.50 million and the government and institutional activity accounts for 0.59% or \$1.17 million.

We trust these comments will aid you in the understanding of this report.
