

Weekly Action Tracker

The Weekly Action Tracker includes all complaints and requests for service received by Housing Focused Street Outreach regarding prospective encampment sites. Occasionally after a site has been designated by staff as cleared, different individual(s) may move into the same location and erect a new tent. To maintain clarity and ensure individuals are given an opportunity to be informed of the Encampment Protocol, anytime new tents are discovered in an area that has been previously cleared, the process will restart with Housing Focused Street Outreach attending to engage. All sites that have previously met compliance will be identified as a 'new' site when new tents begin to populate a non-compliant space.

Site-specific notes:

Woodlands Park: When individuals with acute needs are required to move because their site is in violation of the Encampment Protocol, Housing Focused Street Outreach work collaboratively with Municipal Law Enforcement and Hamilton Police Services to mitigate any potential risks to the wellbeing of the individual, and provide an equitable response as informed by a human-centered, health-focused approach. This has resulted in significant delays to enforcement.

JC Beemer Park: The site was escalated by Municipal Law Enforcement to Hamilton Police Services for enforcement on August 31, 2023. Notably, Hamilton Police do not have service levels associated with enforcement action, and develop specific enforcement plans for each site to gain compliance, which has not yet been achieved at this site.

Escalated Sites (previous three weeks) and Site Status Updates

The following chart maintains a log of all sites that were escalated to Municipal Law Enforcement from Housing Focused Street Outreach in the past three weeks, as well as sites that have experienced a change in status. Note, this does not include active sites nor sites identified in the past week. In addition, sites located on private property that have been escalated to the appropriate enforcement body (e.g., Hamilton Police Services), will be labeled as 'Private Property - Escalated.'
