

INTRODUCTION

Property owners (i.e. home and business owners) and occupants are responsible for clearing and removing snow and ice off sidewalks surrounding their properties within 24 hours after the snow has stopped falling. This includes the portion of the sidewalk at street corners also known as access ramps that allow pedestrians including customer service workers, those who use mobility aids and strollers easier entry to be able to cross the road.

When clearing sidewalks it is important to know that it is illegal to place/throw snow and ice on a road or boulevard. Doing this can interfere with traffic, may cause an accident and could result in a ticket.

Keeping sidewalks and walkways clear improves the quality of life for all and will also help reduce injuries caused by slips and falls.

WHAT IS THE LAW REGARDING SNOW AND ICE REMOVAL?

Property owners and occupants are responsible for the complete removal and clearing of snow and ice:

- From all City sidewalks surrounding their property within 24 hours of a snowfall
- That builds up on roofs or eaves that overhang a City Sidewalk
- From walkways, stairs, and other areas of a property where safe passage is needed

WHAT SHOULD I REMEMBER?

For safety reasons when clearing snow and ice ensure that it is not placed:

- on a road or boulevard
- immediately beside or blocking access to a fire hydrant
- in such a manner that it would block drainage to any drain or sewer

It is illegal to place snow and ice on a road or boulevard and could result in a ticket. Doing this will interfere with traffic and may also cause an accident.



WHAT ARE THE PENALTIES FOR NOT CLEARING SNOW AND ICE?

Failure to remove and clear snow and ice within 24 hours of a snow fall, may result in one or all of the following:

- a Notice to Comply being issued (a document provided to the property owner/occupant on what actions need to be taken). See sample on the next page.
- charges under the Provincial Offences Act, which provide for a maximum fine(s) of \$5000.00, in addition to other court proceedings necessary to obtain compliance.
- fee for inspection costs added to the property taxes.
- the City removing it at the property owner's expense and the costs being added to the property taxes.

WHAT ARE SOME TIPS I SHOULD REMEMBER WHEN CLEARING SNOW AND ICE?

- Apply gravel, salt, clay kitty litter or sand to help.
- If you have a driveway, use it and keep your vehicles off the road during and immediately following a snowfall. This will ensure thorough ploughing of roadways and your vehicle will not get plowed in.
- Shovel early and often; new snow is lighter than packed/partially melted snow.

WHAT CAN I DO TO MAKE SURE MY NEIGHBOUR'S SIDEWALKS ARE CLEAR?

Be a Good Neighbour - Take the Time to Help

Helping people is a wonderful way to build positive relationships and to assist those who are not able to clear the snow. This By-law is intended to allow all people including senior citizens, persons with disabilities, children and service workers the ability (freedom) to use sidewalks safely. If snow is not removed in a timely fashion people may have difficulties receiving services such as Home Care and DARTS.



ARE THERE PROGRAMS THAT CAN ASSIST SENIORS AND DISABLED PERSONS?

Low income Seniors and low-income persons with disabilities may be eligible to receive financial assistance to pay for snow clearing from their sidewalk. To learn if you might qualify, or for other community resources to assist with snow clearing, visit:

You can use the funds provided to hire a company, a neighbor or friend to remove snow from your sidewalk, front walkway and snow plow windrow.


