




#### **Road Network and Classifications**

This map shows the current road network shown in the Airport Employment Growth District Secondary Plan, which came into effect in 2016.




#### **Road Phasing Plan**




#### **Potential Transit Routes**

This map shows the current planned transit routes shown in the Airport Employment Growth District Secondary Plan, which came into effect in 2016.




#### **Natural Heritage System Adjustments**

This map shows the current Natural Heritage System as shown in the Airport Employment Growth District Secondary Plan, which came into effect in 2016.




#### **Natural Heritage System Adjustments**

This map shows the natural heritage features identified in the Subwatershed Study and Stormwater Master Plan Implementation Document, approved in 2017.




This map shows the adjustments made to natural heritage boundaries based upon environmental studies completed as part of development applications that have staff support and Council approvals.



This map shows the natural heritage features identified in the Subwatershed Study and Stormwater Master Plan Implementation Document, approved in 2017.




This map shows the adjustments made to natural heritage boundaries based upon environmental studies completed as part of development applications that have staff support and Council approvals.




## Active Transportation Network The vision for the Airport Employment Growth District contemplates a multi-modal, integrated

The vision for the Airport Employment Growth District contemplates a multi-modal, integrated transportation network. These maps display how that framework is proposed to change. This map shows the proposed multi-use trail facilities currently in the Airport Employment Growth District Secondary Plan. (This map is consolidated with the future transit routes map.)



This map shows the pedestrian and trail facilities that were approved in the 2023 Airport Employment Growth District Transportation Master Plan Update. This would become an "appendix" map in the Secondary Plan to support implementation of the future pedestrian and active transportation network, and separated from the transit information.
