As a result of life-cycle maintenance requirements, Ancaster Municipal Service Centre, otherwise known as "Ancaster Square", located at 300 Wilson Street East will undergo the replacement of the roof and HVAC. The project is currently in the pre-construction stage at this time. Disruptions to the facility are expected to include a total loss of heating, ventilation, and air conditioning (HVAC), including air intake and circulation, as well as ongoing noise, odour, and power disturbances. Due to this necessary work, a planned closure will take effect from May 5<sup>th</sup> to June 2<sup>nd</sup>, 2025, with a contingency duration beyond the June 2<sup>nd</sup> completion date, weather dependent. Due to the majority of the work being weather dependent (roof replacement), delays can be anticipated, and the public's patience is appreciated. Should the construction extend past the June 2<sup>nd</sup> completion date, this will be communicated to Council and the stakeholders with a minimum one-week's notice.

During the closure, the facility parking lot will also be impacted due to the presence of large equipment and the need for construction hoarding. Nearby parking, including accessible parking, is available behind the facility off of Lodor Street, adjacent to the Ancaster Municipal Lawn Bowling Club, located at 291 Lodor Street.
