- o A signed Residential Driveway Boulevard Parking Acknowledgement (if applicable)
- Note: There will a non-refundable application fee of \$489 which includes HST.
 - In addition to the application fee, upon approval of the driveway, there will be an additional cost for the construction of the approach ramp.
