

### HARBOURFRONT STORMWATER CREDIT APPLICATION FORM

### Purpose of this Form

This form is exclusively for Industrial, Commercial, and Institutional (ICI) property owners seeking a Harbourfront Stormwater Credit when stormwater is discharged directly or indirectly into Lake Ontario without utilizing municipal infrastructure.

#### General

The City of Hamilton collects information under authority of Section 227 of the Municipal Act, 2001. Any personal information collected for Stormwater Incentive Program will be used to ensure eligibility for the Stormwater Incentive Program Rebates. By providing your email address, you are consenting to receiving emails from the City of Hamilton and/or their agents/contractors to verify the details of the incentive and ensure the garden or measure is in operational condition and effective. Information collected for this initiative may be stored on servers located in Canada and the United States and may be subject to Canadian and/or American laws. A Stormwater Credit shall expire five years from the date of approval unless the approval is revoked. Stormwater Credit recipients must ensure that they report any changes to the on-site stormwater measures that would reduce a property's eligible credit amount via this application form.

Consumers whose premise is not in compliance with any of the provisions of the Sewer Use By-law, No. 14-090, as amended, are not eligible for the Stormwater Rate Incentive Program, along with consumers who are not in good financial standing with the City of Hamilton.

The General Manager or an Officer may enter on land at any reasonable time and in accordance with the conditions set out in sections 435 and 437 of the Municipal Act, 2001, to carry out an inspection.

- 2. This application form must be fully completed before it will be considered for approval by the City. Incomplete applications for the Stormwater Rate Incentive Program will not be accepted. A complete application consists of a fully completed and signed Application Form. The information submitted in this application form and accompanying documents is subject to verification by the City.
- 3. Additional information may be required to be submitted by an applicant during the review of application for the Stormwater Rate Incentive Program including but not limited to engineering reports, drawings, or maintenance records. The City will contact the Applicant in writing, should additional information be required.

Report, certified by a qualified Professional Engineer, that demonstrates the percentage of stormwater run-off that is conveyed directly to Lake Ontario through overland flow and/or private infrastructure (e.g., private sewers and outfalls). The report should include the following items, where applicable:

Engineering drawings

Supporting calculations and/or modelling results

**Operation and Maintenance Plan Management** 

Confirmation that the system is in good working order

#### **Credit Renewal**

The report, certified by a qualified Professional Engineer, which confirms that the previously approved measures continue to be in a state of good repair, including:

Inspection and maintenance logs

Updates to drawings, calculations, operation and maintenance plan (if applicable)
