BY-LAW NO. 25-097

**Respecting Removal of Part Lot Control
Part of Lots 5 to 8, 10, 16, 18 to 20, 24 to 26, and 28 (All Inclusive), on
Registered Plan of Subdivision No. 62M-1301, Municipally Known as 12, 16,
20, and 24 Dunlop Road, 64, 72, 76, 80, and 85 Alexsia Street, and 295, 303,
307, and 311 Shady Oaks Trail, Hamilton (Ward 8)**

WHEREAS the sub-section 50(5) of the *Planning Act*, R.S.O. 1990, Chapter P.13, as amended, establishes part-lot control on land within registered plans of subdivision;

AND WHEREAS sub-section 50(7) of the *Planning Act*, provides as follows:

“(7) **Designation of lands not subject to part lot control.** -- Despite subsection (5), the council of a local municipality may by by-law provide that subsection (5) does not apply to land that is within such registered plan or plans of subdivision or parts of them as are designated in the by-law.”

AND WHEREAS the Council of the City of Hamilton is desirous of enacting such a by-law with respect to the lands hereinafter described;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Subsection 5 of Section 50 of the *Planning Act*, for the purpose of creating 13 access and maintenance easements, shown as Parts 1 to 13 on Deposited Reference Plan 62R-22529, shall not apply to the portion of the Registered Plan of Subdivision that is designated as follows, namely:

Part of Lots 5 to 8, 10, 16, 18 to 20, 24 to 26, and 28 (All Inclusive), on
Registered Plan of Subdivision No. 62M-1301, in the City of Hamilton.

2. This By-law shall be registered on title to the said designated land and shall come into force and effect on the date of such registration.
