## **BY-LAW NO. 25-099**

To Permanently Close and Sell a Portion of the Unassumed Alleyway Abutting the South Side of 39 Grosvenor Avenue South, Hamilton; Being Part of the Alley lying South of Lots 44 and 65 and North of Maple Avenue, on Registered Plan 586, in the City of Hamilton, Designated as Part 2 on Plan 62R-22434, being Part of PIN 17229-0102 (LT)

**WHEREAS** sections 8, 9 and 10 of the *Municipal Act, 2001* authorize the City of Hamilton to pass by-laws necessary or desirable for municipal purposes, and in particular by-laws with respect to highways; and

**WHEREAS** section 34(1) of the *Municipal Act, 2001* provides that a by-law permanently closing a highway does not take effect until a certified copy of the by-law is registered in the proper land registry office; and

**WHEREAS** highways to be closed by by-law are declared to be surplus to the needs of the City of Hamilton under the Sale of Land Policy By-law; and

WHEREAS at its meeting of September 11, 2024, Council approved of Item 2 of Public Works Committee Report 24-011 and authorized the City of Hamilton to permanently close and sell a portion of the Unassumed Alleyway Abutting the South Side of 39 Grosvenor Avenue South, Hamilton; Being Part of the Alley lying South of Lots 44 and 65 and North of Maple Avenue, on Registered Plan 586, in the City of Hamilton. Designated as Part 2 on Plan 62R-22434, being Part of PIN 17229-0102 (LT); and

**WHEREAS** notice to the public of the proposed sale of the part of the road allowance has been given in accordance with the requirements of the Sale of Land Policy By-law.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

To Permanently Close and Sell a portion of the Unassumed Alleyway Abutting the South Side of 39 Grosvenor Avenue South, Hamilton; Being Part of the Alley lying South of Lots 44 and 65 and North of Maple Avenue, on Registered Plan 586, in the City of Hamilton, Designated as Part 2 on Plan 62R-22434, being Part of PIN 17229-0102 (LT)

1. The part of the unassumed alleyway set out as follows:

Part of the Alley lying South of Lots 44 and 65 and North of Maple Avenue, on Registered Plan 586, in the City of Hamilton. Designated as Part 2 on Plan 62R-22434, being Part of PIN 17229-0102 (LT);

is hereby permanently closed.

- 2. The soil and freehold of Part 2 on Reference Plan 62R-22434, hereby permanently closed, be sold to Nina Joesphine Stratemeyer and Matthew George Twynstra.
- 3. That this by-law shall come into force and effect on the date of its registration in the Land Registry Office for the Land Titles Division of Wentworth (No. 62).
