#### **Terms within Waste Hauler Application Package**

**Hauled Sewage** – This encompassing term includes various types of hauled or carried waste, the breakdown includes: Industrial Sewage; Domestic Sewage; Sewage Sludge; Leachate; Sewer Maintenance Cleaning

**Industrial Sewage** – means sewage from any agricultural, commercial, industrial or institutional premises or any other premises where the sewage includes significant quantities of sewage of non-human origin or differs significantly from domestic sewage.

**Domestic Sewage** – means waste that is human body waste, toilet or other bathroom waste, waste from showers or bathtubs, liquid or water borne culinary or sink waste or residential laundry waste. *This can include waste from portable toilets or vessel blackwater, meaning "black water tank vessels containing contents as above are considered.* 

**Sewage Sludge** – means semi-solid material recovered from the sewage treatment facility process. Note that this does not include sewage sludge from an industrial facility - that would fall under industrial sewage.

Leachate from a waste disposal site.

**Sewer Maintenance Cleaning** – means contracted City of Hamilton maintenance cleaning of wastewater/stormwater infrastructure.

#### **RE: Hauled Sewage Permitting Requirements**

21 November 2024

Dear User,

Carriers of Hauled Sewage and Generators of Hauled Sewage discharging industrial sewage at a waste hauling facility <u>without a generator permit</u> issued by the City is a <u>prohibited activity</u>.

Section 9.3(c) Prior to each discharge, submits a signed, completed and legible Hauled Sewage Discharge Declaration to the City at the hauled sewage receiving facility.

Section 9.6(a) of the Sewer Use By-law 14-090, permits the above activity where a valid Generator Permit application has been submitted, verified, and approved.

The City of Hamilton requires that all hauled industrial sewage being discharged at a hauled sewage receiving facility in Hamilton is from a permitted generator facility.

#### What does this mean for you as a hauler?

Carriers of hauled sewage who discharge industrial sewage must identify the Generator Permit # on all applicable discharge declaration forms.

Generators of hauled industrial sewage who discharge or permit the discharge of sewage sludge/industrial waste must be communicating and providing their Generator Permit # to carriers prior to waste pickup & disposal. Failure to provide a Generator's Permit # for industrial sewage may result in a refusal of entry.

<sup>1</sup>A permit is required to purchase 2025 tanker tickets and discharge hauled sewage or industrial wastes at City of Hamilton facilities.

## 2. Unused 2024 Tickets

- All outstanding 2024 Tanker Tickets will be accepted for use and refund up to and including February 14, 2025.
- Waste haulers will be granted access to discharge up to and including January 31, 2025 with their 2024 windshield permit stickers.
- Waste haulers with 2024 permits may purchase 2025 Tanker Tickets up to and including January 31, 2025.

## 3. Required Documents

To obtain a permit, all waste haulers are required to submit the 9 documents outlined below in Table 2.

To ensure your application is processed quickly, please ensure all areas are complete and legible, and all required documentation and fees are included. The following table is also a checklist and will assist you in ensuring your application package is complete:

After hours discharge is the activity of accessing the Woodward Avenue Wastewater Treatment Plant outside of operating hours listed above, to discharge waste.

To discharge after hours, advanced permission is required and shall be obtained either by a preplanned request, or on an emergency basis:

#### 1. Pre-planned After-hours Discharges

To obtain permission for pre-planned after-hours discharges, contact

sewerusebylaw@hamilton.ca at least one week in advance, and provide the following details:

- Name of waste hauler company
- Source and type of the wastewater including company name, complete address, and generator permit number (if applicable)
- Reason after-hours discharge is requested
- Estimated number of truck loads to discharge
- Estimated time(s) of discharge(s)

## 2. <u>Emergency Discharges</u>

To obtain permission for after-hours emergency discharges:

- i. Call the 905-546-2489.
- ii. Your request will be routed to an on-call Environmental Enforcement Officer (EEO) who will return your call and obtain the information required to approve your discharge.
- iii. If approved, the EEO will relay this information to the security guard at Woodward Avenue.

Driver's must follow the direction given by city staff while onsite and must submit the Hauled Wastewater Discharge Declaration and payment tickets to the security guard on duty before discharging.
