MONTHLY PERMIT REPORT**

To Subscribers:

Re: Monthly Report for the month of August 2025

In August the Building Division issued 468 building permits valued at \$90.96 million.

For the month, the residential component was the strongest accounting for 73.77% of the month's total and is valued at \$67.10 million. Of the 294 permits in the residential category, 79 permits were issued for new single-family dwellings at a total value of \$28.14 million. Commercial activity accounts for 9.85% or \$8.96 million with 51 permits issued. Industrial activity accounts for 8.32% or \$7.57 million and the government and institutional activity accounts for 5.52% or \$5.02 million.

We trust these comments will aid you in the understanding of this report.
