The purpose of the visit by this Ontario Ministry of Labour, Immigration, Training and Skills Development (MLTSD) Inspector today, was to review compliance with an order issued during field visit #4773CTPWMLH-4773-FV005 dated January 13, 2025.

INSPECTOR ACTIONS/FINDINGS:

Order #- 4773CTPWMLH-4773-OR002 (Comply-by-date October 31, 2025)-

The employer is requesting an extension of order #2 for the following reason:

Of the 526 workers to complete training 403 are complete (78.4%). The employer requires more time of complete the remaining training.

The employer stated the Joint Health and Safety Committee is aware and agreeable to the extension.

The employer stated interim measures for the protection of workers from workplace violence is in place during the extension period.

The extension is granted, the new compliance date is January 30, 2026.
