# To Amend Zoning By-law No. 05-200 Respecting Lands Located at 1107 Main Street West, Hamilton

**WHEREAS** under the provisions of Subsection 29.2(1) of the *Planning Act*, as amended by Bill 13, the *Supporting People and Businesses Act, 2021*, a council of a local municipality may, by by-law, delegate the authority to pass by-laws under Section 34 of the *Planning Act* that are of a minor nature to a committee of council or an individual who is an officer, employee or agent of the municipality;

- 1. That Map No. 949 of Schedule "A" Zoning Maps is amended by changing the zoning from the Transit Oriented Corridor Mixed Use Medium Density (TOC1, 772, H75) Zone, to the Transit Oriented Corridor Mixed Use Medium Density (TOC1, 772) Zone, for the lands identified in Schedule "A" attached hereto.
- 2. That Schedule "D" Holding Provisions is amended by deleting Holding Provision H75 from the lands identified in the Location Map attached as Schedule "A" to this By-law.
- 3. That the Clerk is hereby authorized and directed to proceed with the giving of notice of passing of this By-law in accordance with the *Planning Act*.
