## **BY-LAW NO. 25-180**

To Permanently Close and Sell a Portion of Public Road Allowances Abutting 95 Dundurn Street South, Hamilton; Being Firstly: Part of Lots 1 & 2 on Registered Plan 416, City of Hamilton, Designated as Part 2 on Plan 62R-22567; Being Part of PlN 17139-0138 (LT); and Secondly: Part of Lot 1 on Registered Plan 416, City of Hamilton, Designated as Part 3 on Plan 62R-22567; Being All of PlN 17139-0320 (LT)

**WHEREAS** sections 8, 9 and 10 of the *Municipal Act, 2001* authorize the City of Hamilton to pass by-laws necessary or desirable for municipal purposes, and in particular by-laws with respect to highways; and

**WHEREAS** section 34(1) of the *Municipal Act, 2001* provides that a by-law permanently closing a highway does not take effect until a certified copy of the by-law is registered in the proper land registry office; and

**WHEREAS** highways to be closed by by-law are declared to be surplus to the needs of the City of Hamilton under the Sale of Land Policy By-law; and

WHEREAS at its meeting of July 16, 2025, Council approved of Item 8.1 of Public Works Committee Report 25-008 and authorized the City of Hamilton to permanently close and sell a portion of public road allowances abutting 95 Dundurn Street South, Hamilton; Being Firstly: Part of Lots 1 & 2 on Registered Plan 416, City of Hamilton, Designated as Part 2 on Plan 62R-22567; Being Part of PIN 17139-0138 (LT); and Secondly: Part of Lot 1 on Registered Plan 416, City of Hamilton, Designated as Part 3 on Plan 62R-22567; Being All of PIN 17139-0320 (LT); and

**WHEREAS** notice to the public of the proposed sale of a portion of public road allowances have been given in accordance with the requirements of the Sale of Land Policy By-law.

Secondly: Part of Lot 1 on Registered Plan 416, City of Hamilton, Designated as Part 3 on Plan 62R-22567; Being All of PIN 17139-0320 (LT)

are hereby permanently closed.

- 2. The soil and freehold of Parts 2 and 3 on Reference Plan 62R-22567, hereby permanently closed, be sold to Sacajawea Non-Profit Housing Inc.
- 3. That this by-law shall come into force and effect on the date of its registration in the Land Registry Office for the Land Titles Division of Wentworth (No. 62).
