To Permanently Close and Sell a Portion of the Road Allowance known as 37 Mountain Avenue North, Hamilton; Being Part of Lot 62 on Registrar's Compiled Plan 1424 in the Geographic Township of Stoney Creek, in the City of Hamilton, Designated as Parts 1 and 2 on Plan 62R-22501, Being all of PIN 17318-0109 (LT)

WHEREAS sections 8, 9 and 10 of the *Municipal Act, 2001* authorize the City of Hamilton to pass by-laws necessary or desirable for municipal purposes, and in particular by-laws with respect to highways; and

WHEREAS section 34(1) of the *Municipal Act, 2001* provides that a by-law permanently closing a highway does not take effect until a certified copy of the by-law is registered in the proper land registry office; and

WHEREAS highways to be closed by by-law are declared to be surplus to the needs of the City of Hamilton under the Sale of Land Policy By-law; and

WHEREAS at its meeting of October 9, 2024, Council approved of Item 6 of Public Works Committee Report 24-013 and authorized the City of Hamilton to permanently close and sell a portion of the Road Allowance known as 37 Mountain Avenue North, Hamilton; Being Part of Lot 62 on Registrar's Compiled Plan 1424 in the Geographic Township of Stoney Creek, in the City of Hamilton. Designated as Parts 1 and 2 on Plan 62R-22501. Being all of PIN 17318-0109 (LT).

WHEREAS notice to the public of the proposed sale of the part of the road allowance has been given in accordance with the requirements of the Sale of Land Policy Bylaw.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. The part of the road allowance set out as follows:
