# Urban Hamilton Official Plan Amendment No. 238

The following text constitutes Official Plan Amendment No. 238 to the Urban Hamilton Official Plan.

## 1.0 **Purpose and Effect**:

The purpose and effect of this Amendment is to amend the policies of Volume 1 and Volume 2 of the Urban Hamilton Official Plan to establish permissions for schools in the Urban Area on any residential lot or lot with permissions for standalone residential uses.

## 2.0 Location:

The lands affected by this Amendment are located within the Urban Area of the City of Hamilton.

## 3.0 Basis:

The basis for permitting this Amendment is:

- To update the Urban Hamilton Official Plan to reflect amendments to the *Planning Act* through Bill 17, *Protect Ontario by Building Faster and Smarter Act. 2025.*
- The proposed Amendment is consistent with the Provincial Planning Statement, 2024.
