**Cormorant Road Extension
From Tradewind Drive to Trinity Road South**

THE PROJECT AND PROCESS

The City of Hamilton has completed the Municipal Class Environmental Assessment (Class EA) to determine the optimal location of an extension of Cormorant Road, between Tradewind Drive to Trinity Road South. The preferred alternative identified by the Class EA is to construct Cormorant Road by extending it directly to Trinity Road South (straight line) from Tradewind Drive.

The Class EA Study has been conducted in accordance with Schedule “B” of the Municipal Class EA for Municipal Roads (*Municipal Engineers Association, October 2000 as amended in 2007, 2011*).

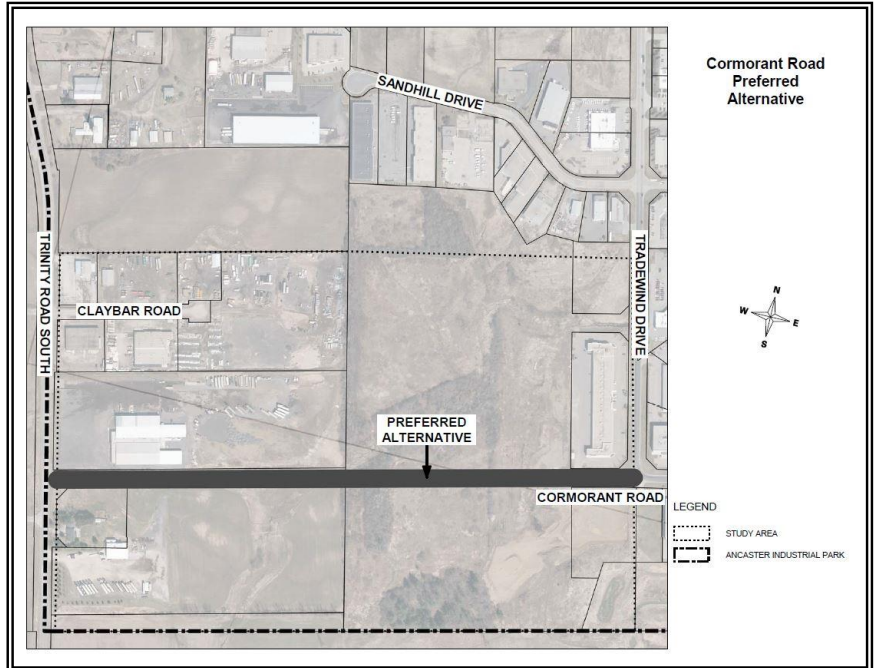
PUBLIC REVIEW PERIOD
