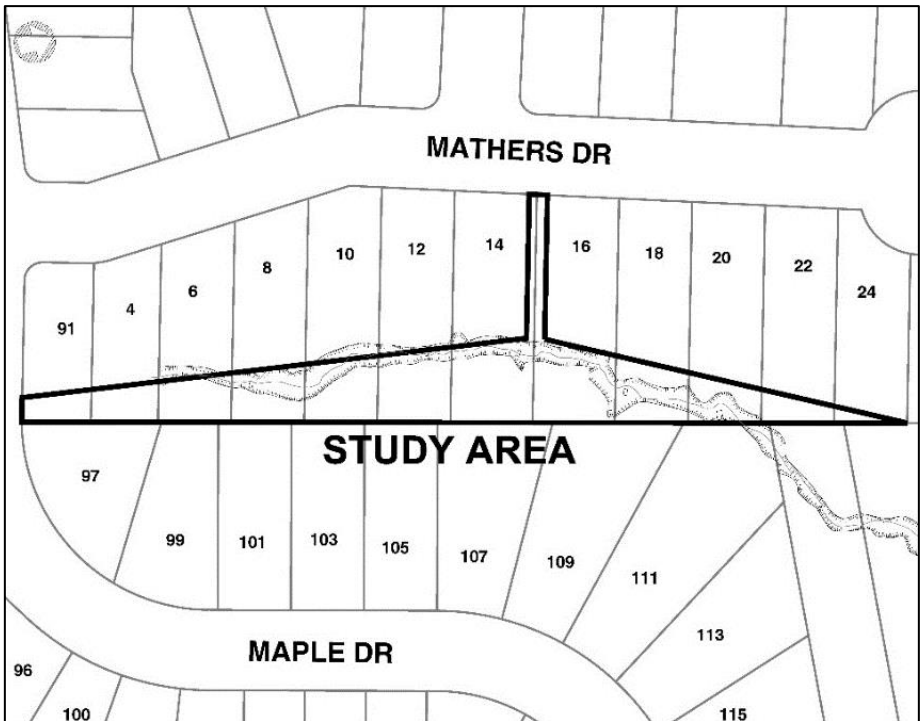

Mathers Drive Stream & Valley Wall Erosion Schedule 'B' Class Environmental Assessment Study

The City of Hamilton has initiated a Schedule 'B' Class Environmental Assessment (EA) study to determine the preferred alternative to protect homes in the community from erosion and valley slope failure as a result of deteriorated erosion control structures. This study includes public and review agency consultation, evaluation of alternatives, assessment of the impacts of the proposed works, and identification of measures to mitigate any adverse impacts. Upon completion of the study, a Project File Report documenting the planning and decision making process followed, will be prepared and made available for public review.

The Study Process

This Study is being carried out as a Schedule 'B' project in accordance with the planning and design process as defined in the Municipal Engineers Association Municipal Class Environmental Assessment document (October 2000, as amended in 2007, 2011, 2015).



A key component of the study will be consultation with interested stakeholders (public, land owners and regulatory agencies). A Public Information Centre (PIC) will be held to provide interested parties with an opportunity to review and discuss issues related to the study.
