**CITY OF HAMILTON**

**BY-LAW NO. 17-017**

**To Amend By-law No. 01-218, as amended,  
Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*,

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

"Lloyminn Av.	South	from 29.5m west of the extended west curb line of Wilderness Dr. to 74.3m westerly	Anytime:
---------------	-------	---	----------

and by deleting from Section "E" thereof the following item, namely:

"Jacqueline Blvd.	South & East	From 60m west of Piano Dr. to 12m westerly and 17m southerly along the inside of bend	Anytime"
----------------------	-----------------	--	----------

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

(Page 2 of 2)

"Minto	East	from 19.8m south of the extended south curb line of Bristol to 5.3m southerly	Anytime
Park Row	East	from 25m north of Dunsmure to 6.4m northerly	Anytime"

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Duke	South	Queen to 18m easterly	Anytime"
-------	-------	-----------------------	----------

and by adding to Section "E" thereof the following items, namely:

"Duke St.	South	Queen St. to 40.9m easterly	Anytime
Duke St.	South	from 63.9m m east of Queen St. to 11.5m easterly	Anytime"

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
