## **CITY OF HAMILTON**

### **BY-LAW NO. 17-027**

**To Authorize the Execution of a Contribution Agreement between the City of Hamilton and Her Majesty the Queen in right of Canada as represented by the Minister responsible for the Federal Economic Development Agency for Southern Ontario to Receive Funding Under the Canada 150 Community Infrastructure Program Intake Two**

**WHEREAS** on the 22<sup>nd</sup> day of June, 2016, the Council of the City of Hamilton did approve of Item 19 of General Issues Committee Report 16-016 and authorized the City of Hamilton to apply to receive funding for projects under the Canada 150 Community Infrastructure Program Intake Two;

**AND WHEREAS** the Federal Economic Development Agency for Southern Ontario has approved funding for eleven City of Hamilton projects under the Canada 150 Community Infrastructure Program Intake Two listed in Schedule 1 to this By-law;

**AND WHEREAS** at its meeting on June 22, 2016, the Council of the City of Hamilton also authorized the signing of a contribution agreement with Her Majesty the Queen in right of Canada as represented by the Minister responsible for the Federal Economic Development Agency for Southern Ontario to receive funding for the approved projects under the Canada 150 Community Infrastructure Program Intake Two;

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. The following Schedule forms part of this By-law:

Schedule 1 – Approved City of Hamilton Canada 150 Community Infrastructure Program Projects Intake Two

2. The projects listed in Column 1 of Schedule 1 have been approved by the Federal Economic Development Agency for Southern Ontario to receive the corresponding funding amount in Column 2 under the Canada 150 Community Infrastructure Program Intake Two.

4. This By-law shall come into effect upon its passing.
