CITY OF HAMILTON

BY-LAW NO. 17-029

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following items, namely:

"Avatar Pl.	North & West	from 78.4m east of Stoneglen Wy. To 13.7m easterly and northerly along the curb line	Anytime
Celestial Cr.	East	from 143.7m north of the western intersection with Bellagio Av. to 6.7m northerly	Anytime
Celestial Cr.	East & South	from 168.4m north of the western intersection with Bellagio Av. to 21.1m northerly and easterly along the curb line	Anytime
Celestial Cr.	West	from 148.2m north of the eastern intersection with Bellagio Av. to 6.4m northerly	Anytime
Celestial Cr.	West &	from 166.8m north of the	Anytime

	South	eastern intersection with Bellagio Av. to 21m northerly and westerly along the curb line	
Lynch Cr.	North	from 93.3m north and west of the eastern intersection with Gowland Dr. to 8.1m westerly	Anytime
Pelech Cr.	East & North	from 138.9m south of the western intersection with Pinehill Dr. to 20.3m southerly and easterly along the curb line	Anytime
Pelech Cr.	West & North	from 157.3m south of the eastern intersection with Pinehill Dr. to 21.3m southerly and westerly along the curb line	Anytime”

and by adding to Section "E" thereof the following items, namely:

“Bold	North	Bay to 68.7m westerly	7:00 a.m. to 12 Noon Mondays & Thursdays
Bold	South	Bay to 81.5m westerly	7:00 a.m. to 12 Noon” Mondays & Thursdays

- Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Bold	North	from 74.7m west of Pearl to 6m westerly	Anytime”
