## **CITY OF HAMILTON**

### **BY-LAW NO. 17-178**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*,

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Hatt St. South from 31.7m west of Kerr St. and extending 7m westerly. 1 hr 8 am - 6 pm Mon – Fri"

And by deleting from Section "B" the following items, namely:

"Hatt South from 23.9m west of Kerr to 21.6m westerly 1 hr 8 am - 6 pm Mon – Fri"

And by adding from Section "E" the following items, namely:

"Main St. E. North Sanford Ave. S. to Sherman Ave. S. 1hr 8 am - 6 pm Mon – Sat"

"Main St. E. North Garfield Ave. S. to 19.4m west of Prospect St. S. 1hr 8 am - 6 pm"

"Caroline St. West from 20m north of Charlton Ave. W. 15 min Anytime Mon-Fri"

Being a By-law to Regulate On-Street Parking

“Allenby Ave. both from Southbend Rd. E. to McElroy Rd. E. 1 hr 8 am - 6 pm

“Main North Sanford Ave. S. to 19.4m west of Prospect 1 hr 8 am - 6 pm Mon –  
Sat”

“MacNab St. N. East Barton St. W. to Colborne St. 1 hr 8 am - 8 am (24 hrs)  
Mon – Sun”

“Gage Av. West from 65.2m south of Maplewood Av. to 20.4m southerly 30 min  
Anytime Anyday”

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

“Greening Court North and South commencing 46m west of Cameron Ave. and extending westerly and southerly around the cul-de-sac. 8:00 a.m. to 12:00 p.m. Every Thursday”

“Hatt St. South Commencing 54.7m from Kerr St. and extending westerly to Ogilvie St. Anytime”

And be adding from “Section E” the following items, namely:

“Main St. E. North Sherman Ave. S. to Garfield Ave. S. Anytime”

“Victor Blvd. North Commencing 6.9m east of the north/south portion of Victor Blvd. and extending 6.0m easterly Anytime”

“Victor Blvd. South Commencing 23.9m west of Ridge St. and extending 6m westerly Anytime”

“Gage Ave. S. West from 65.2m south of Maplewood Ave. and extending 6m southerly Anytime”

“Bold St. North commencing 51m from west of Caroline St. S. and extending 4m westerly Anytime”

“Springer Ave. West Maplewood Ave. to Main St. E. Anytime”

“Springer Ave. West Main St. E. to 23.1m southerly Anytime”

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

(Page 3 of 5)

“Springer Ave. West From 37.2m south of Main St. E. to Maplewood Ave. Anytime”

And by deleting from “Section E” the following items, namely:

“Hillcrest South Dundurn to 72m easterly 7:00 a.m. to 6:00 p.m. Monday to Friday”

“Hillcrest South Mountain to easterly end 7:00 a.m. to 6:00 p.m. Monday to Friday”

3. Schedule 9 (Full Time Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

“East 25th St. From Brucedale to Queensdale East West”

4. Schedule 10 (Alternate Side Parking April to November) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

“Chambers Dr. from Regan St. to Lockman St. West East”

5. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

“Brock St. N. East from 30.8 m south of Melville St. and extending 6m southerly. Anytime”

And by adding to “Section E” the following items, namely:

“Biggar Ave. North commencing 171.7m west of Lottridge St. and extending 5.4 westerly. Anytime

Hillyard St. West commencing 75m north of Burlington St. E. and extending 6m northerly. Anytime

Florence St. South from 44.3m west of Pearl to 6m westerly Anytime

London St. N. East from 66.2m north of Roxborough Ave. and Extending 5.4m north. Anytime

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

(Page 4 of 5)

Paling Ave. N. West from 51.4m north of Vansitmart Ave. and extending 5.7m north. Anytime”

And by deleting from Section “E” the following items, namely:

“Inchbury East from 57m south of York to 5m southerly Anytime

Agincourt East from 67.6m north of McAnulty to 6m northerly Anytime

Catharine East from 12.5m north of Wood to 5.5m northerly Anytime

Kensington West from 22.5m south of Campbell to 6.5m southerly Anytime

Locke East from 10.6m south of Homewood to 4.6m southerly Anytime

London St. West from 42.3m south of Edinburgh St. to 5.5m southerly  
Anytime

Robinson South from 66.5m west of Caroline to 6m westerly Anytime

Fairfield West from 27m south of Vansitmart to 5.5m southerly Anytime

Grosvenor East from 52.6m north of Dunsmure to 4.9m northerly Anytime

Grosvenor West from 61.6m north of Dunsmure to 6m northerly Anytime

Gordon South from 76.5m west of Lincoln to 6m westerly Anytime

Barnesdale Ave. S. East from King St. E. to Vineland Ave. Anytime

Macnab St. N. East from Colborne St. to Barton St. W. Anytime”

And by deleting from “Section F” the following items, namely:

“Jones North from 43.9m east of Mountain to 5.6m easterly Anytime”

6. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

“Hatt St. South Commencing 38.7m west of Kerr St. and extending 16m westerly. Anytime”

And by adding to “Section E” the following item, namely:

To Amend By-law No. 01-218, as amended,  
Being a By-law to Regulate On-Street Parking

(Page 5 of 5)

“Meadow Wood Cres. East Commencing 120.4m south of Old Mud St. and extending 29.6m south easterly to White Marks Anytime”

7. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

“Springer Ave. West from 23.1m south of Main St. E. and extending 14.1m southerly. 8:00 a.m. to 4:30 p.m. Monday to Friday

Gage Ave. West from 71.2m south of Maplewood Ave. and extending 14.2m southerly. Anytime”

8. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Caroline West 36 ft. 30 ft. north of Charlton 9:00 A.M. - 5:00 P.M. Mon to Fri”

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

8. This By-law shall come into force and take effect on the date of its passing and enactment.
