## **CITY OF HAMILTON**

### **BY-LAW NO. 17-244**

#### **To Amend By-law No. 01-215 Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to section "B" (Dundas) thereof the following item, namely:

Highland Park Drive	375 m west of Lynndale Drive	75 m west of Lynndale Drive	40 km/h

And by adding to "C" (Flamborough) thereof the following items, namely;

Millgrove Side Road	700 m south of Concession 5	Highway 5	60 km/h
Millgrove Side Road	Highway 6	Concession 5	40 km/h

And by adding to section "E" (Hamilton) thereof the following item, namely;

Southpark Avenue	Upper Wentworth Street	Rushdale Drive	40 km/h

2. Schedule 3 (Flashing School Zones – Reduced Speed Limit) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

Garth Street	Braemar Place to Bendamere Avenue	40	8:10 a.m. to 8:50 a.m. 3:10 p.m. to 3:40 p.m.
Fennell Avenue West	Garth Street to 170 metres West of Auchmar Road	40	8:10 a.m. to 8:50 a.m. 3:10 p.m. to 3:40 p.m.

And by adding to Section "E" (Hamilton) thereof the following item, namely:

Aberdeen Avenue	Chedoke Avenue to Queen Street	40	8:00 a.m. to 9:25 a.m. 11:45 a.m. to 12:55 p.m. 2:40 p.m. to 4:00 p.m.

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
