**CITY OF HAMILTON**

**BY-LAW NO. 04- 242**

**To Amend By-law No. 01-218, as amended,  
Being a By-law To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Augusta Both Catharine to Walnut 1 hr 8 am – 6 pm Mon - Fri”

and by adding to Section "E" thereof the following items, namely:

“Augusta Both Catharine to Walnut 1 hr 8 am – 6 pm Mon – Sat

St. Clair Both Main to Dunsmure 3 hr Anytime Anyday”

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "B" thereof the following item, namely:

“Pleasant Ave. South King’s Gate to the westerly limit of Pleasant Ave. 8:00 a.m. to 7:00 p.m. Monday to Saturday”

and by adding to Section "B" thereof the following item, namely:

“Pleasant Ave.	South	Skyline Dr. to the westerly limit of Pleasant Ave.	8:00 a.m. to 7:00 p.m.” Monday to Saturday

and by deleting from Section "E" thereof the following items, namely:

“Lavina	South	from 134.5m west of Magnolia to 16.8m westerly	Anytime

and by adding to Section "E " thereof the following items, namely:

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Moxley Drive Mohawk Road to Beacon Avenue	East	West”

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Mayflower	South	commencing 95 feet west of Glendale and extending 18 feet westerly therefrom	Anytime”

and by adding to Section "E" thereof the following items, namely:

"Burlington	North	from 26.5m east of Catharine to 7.5m easterly	Anytime
Campbell	South	from 25.3m west of Grosvenor to 6.4m westerly	Anytime
Campbell	North	from 32m west of Grosvenor to 6.4m westerly	Anytime
Garside	West	from 7.3m north of Roxborough to 4.9m northerly	Anytime"

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Hughson	East	from 80.4m north of Simcoe to 46.6m northerly	Anytime"

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Simcoe	North	from 41.5m east of Hughson to 12.2m easterly	7:00 a.m. to 6:00 p.m." Monday to Saturday

7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Hughson	North	Simcoe to 80.4m northerly	7:00 a.m. to 6:00 p.m." Monday to Saturday




9. This By-law shall come into force and take effect on the date of its passing and enactment.<sup>4</sup>
