CITY OF HAMILTON

BY-LAW NO. 04-259

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following item, namely:

"Stagecoach South Drive & West	from 84.4m west of Homebrook Drive to 39m westerly and northerly along the curbline	Anytime"

and by deleting from Section "E" thereof the following items, namely:

"Hughson West	commencing 75 feet south of King and extending 200 feet southerly therefrom	9 am – 4 pm Mon - Fri

2. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Walter Avenue West East”
Melvin Avenue to Barton Street

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

“Clinton North commencing 167 feet west of Lottridge and Anytime
extending 24 feet westerly therefrom

Clinton South commencing 159 feet west of Lottridge and Anytime
extending 18 feet westerly therefrom

Garside West commencing 118 feet south of Roxborough Anytime
and extending 19 feet southerly therefrom

Garside East 117 feet south of Roxborough to 19 feet Anytime
southerly

McAnulty South from a point 38 feet east of the east curb Anytime
line of Benson to a point 25 feet easterly
therefrom

Ray West commencing 51 feet south of York to a point Anytime”
24 feet southerly therefrom

and by adding to Section "E" thereof the following item, namely:

“Chatham North from 140m east of Dundurn to 5.8m easterly Anytime”

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

“Cross St. East Park St. to 23.5m southerly Anytime”

and by deleting from Section "E" thereof the following items, namely:

“Hixon	Both	Mount Albion to 100 feet easterly	Anytime
Hughson	West	King to Main	Mon. – Sat. 7 am – 9 am
Hughson	West	King to Main	Mon. – Sat.” 4 pm – 6 pm

and by adding to Section "E" thereof the following items, namely:

“Hixon	North	Mount Albion to 18m easterly	Anytime
Hixon	South	Mount Albion to 11.9m easterly	Anytime
Sanford	West	from 5.2m south of the extended curb line of Huron to 96.6m southerly	7:00 a.m. to 6:00 p.m.” Monday to Friday

and by adding to Section "F" thereof the following item, namely:

“Highland Road West	North	from 165.8m west of Glenhollow Drive to 36.6m westerly	Anytime”

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

“Grant Boulevard	South	from 15.9m west of the extended curb line of Bertram to 12m westerly	Anytime”

and by deleting from Section "E" thereof the following item, namely:

“East 32 nd	East	from 22m north of Crockett to 5.4m northerly	7:00 am – 6:00 pm” Monday to Friday

“Hixon	North	from 18m east of Mount Albion to 11.9m easterly	Anytime”

6. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Hughson North Simcoe to 80.4m northerly 7:00 a.m. to 6:00 p.m."
Monday to Saturday


and by adding to Section "E" thereof the following item, namely:

"Hughson East Simcoe to 80.4m northerly 7:00 a.m. to 6:00 p.m."
Monday to Saturday

7. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
8. This By-law shall come into force and take effect on the date of its passing and enactment.
