**CITY OF HAMILTON
BY-LAW NO. 05-084
To Amend Bylaw No. 01-215
Being a Bylaw To Regulate Traffic**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the Highway Traffic Act;

AND WHEREAS Section 314(7) of the Municipal Act confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Freeman Pl.	James St. S.	Mountwood Ave.	40
Mountwood Ave.	Freeman Pl.	St. Joseph's Dr.	40"

2. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Catharine Southbound Forest"

and by deleting from Section "G" the following item, namely:

"Charlton Eastbound and Westbound Ferguson"

To Amend By-law 01-215 Being a By-law to Regulate Traffic

3. Schedule 4 (Yield Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" the following items, namely:

"Charlton	Eastbound and Westbound	Ferguson
Charlton	Eastbound and Westbound	Walnut
Ferguson	Northbound and Southbound	Charlton
Walnut	Northbound and Southbound	Charlton
Charlton	Westbound to Northbound	Victoria"

4. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" the following item, namely:

"Charlton	Victoria to a point 30m easterly	North	Anytime	Westerly to Northerly"


5. Schedule 10 (No Left Turns) of By-law No. 01-215, as amended, is hereby further amended by adding to section "E" the following item, namely:

"Arkeldun	Westbound (downbound)	Kingsway	7:00 am to 9:00 am and 4:00 pm to 6:00 pm, Monday to Friday"
-----------	--------------------------	----------	--


6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

7. This By-law shall come into force and take effect on the date of its passing and enactment.
