**CITY OF HAMILTON**

**BY-LAW NO. 05-112**

**To Amend Bylaw No. 01-218, as amended,  
Being a Bylaw To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Pearl East from 162 ft. north of 3 hr 8 am – 8 pm Mon - Sat"  
Tuckett to 36 ft. northerly

and by adding to Section "E" thereof the following items, namely:

"Duff North Upper James to 2 hr 8 am – 6 pm Mon – Fri  
West 2<sup>nd</sup>

Pearl East from 37.9m north of 3 hr 8 am – 6 pm Mon - Fri"  
Tuckett to 56.5m northerly

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Lynden West South St. to Little John Rd. 7:00 a.m. to 5:00 p.m."  
Ave. Monday to Friday

and by deleting from Section "E" thereof the following items, namely:

"King	North	from 87.2m west of Rodgers to 37.5m westerly	Anytime

“Dundas St. North Main St. to West St. 4:00 p.m. to 6:00 p.m.”

and by adding to Section "E" thereof the following items, namely:

“Cranbrook East Greendale to 130.2m northerly 8:00 a.m. to 4:30 p.m.  
Monday to Friday


and by deleting Section "G", in its entirety.
