CITY OF HAMILTON

BY-LAW NO. 05-168

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. By-law 01-218, as amended, is hereby further amended by deleting from the title of Schedule 22 thereof the word "Authorized" and by substituting in its place the word "Official".
2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Currie West from 5.9m north of the 7:00 a.m. to 6:00 p.m."
extended north curb line Monday to Friday
of Beaconsfield to 34.4m
northerly

Currie West from 58m north of the 7:00 a.m. to 6:00 p.m."
Extended north curb line Monday to Friday
of Beaconsfield to 22m
northerly

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"West 2nd East 23 feet commencing 141 feet south Anytime"
of South Bend

6. Schedule 16 (Taxi Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Currie West from 76 feet south of the extended Anytime"
south curb line of Dubarry to
60 feet southerly


7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

“Currie West from 40.3m north of the 7:00 a.m. to 6:00 p.m.”
extended north curb line Monday to Friday
of Beaconsfield to 17.7m
northerly

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
