**CITY OF HAMILTON**

**BY-LAW NO. 05-225**

**To Amend Bylaw No. 01-218, as amended,  
Being a By-law To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 4 (Special Event Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "F" thereof the following items, namely:

"Maple Gate Drive	Highway 8 to Parkmanor Drive
Millikin Drive	Highway 8 to Parkmanor Drive
Parkmanor Drive	Silverlace Circle to easterly end of Parkmanor Drive
Silverlace Circle	Park Manor Drive clockwise to Parkmanor Drive
Yellowwood Drive	Winona Road to Silverlace Circle
Napa Lane	Barton Street to Sonoma Lane
Sonoma Lane	Winona Road to easterly end of Sonoma Lane
Benziger Lane	Winona Road to Napa Lane"

2. Section 1 of this By-Law shall come into force and take effect at 9:00 a.m. on the 26<sup>th</sup> day of August, 2004, and shall be repealed and no longer in force and effect at 1:00 a.m. on the 29<sup>th</sup> day of August, 2004.

3. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Subsection 2(a) of Section "E" thereof (2 hours at 50¢ per hour) the following items, namely:

"East 21 <sup>st</sup>	West	Concession to 36.6m southerly
East 22 <sup>nd</sup>	West	12.2m south of Concession to 21m southerly"

and by adding to Subsection 2(a) of Section "E" thereof (2 hours at 50\$ per hour) the following items, namely:

"East 21 <sup>st</sup>	East	Concession to 38m southerly
East 22 <sup>nd</sup>	Both	Concession to 36m southerly
Concession	South	Upper Wentworth to East 27 <sup>th</sup> "

and by adding to Subsection 3(a) of Section "E" thereof (1 hour at 50¢ per hour) the following items, namely:

"Concession	North	East 16 <sup>th</sup> to East 18 <sup>th</sup>
Concession	South	East 15 <sup>th</sup> to East 18 <sup>th</sup> "

and by deleting from Subsection 2(a) of Section "G" thereof (2 hours at 50¢ per hour) the following items, namely:

"Concession	North	East 18 <sup>th</sup> to East 19 <sup>th</sup>
Concession	North	Upper Wentworth to Upper Sherman
Concession	South	Upper Wentworth to East 27 <sup>th</sup> "

and by deleting from Subsection 3(a) of Section "G" thereof (1 hour at 50¢ per hour) the following items, namely:

"Concession	North	30ft. west of the west curb line of East 16 <sup>th</sup> to a point 25 ft. westerly therefrom
Concession	North	East 16 <sup>th</sup> to East 18 <sup>th</sup>
Concession	South	East 18 <sup>th</sup> to East 15 <sup>th</sup> "

4. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Park West Merrick to Cannon 1 hr 8 am – 6 pm Mon – Sat"

5. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"East 21<sup>st</sup> East Concession to 142 ft. south Anytime

East 22<sup>nd</sup> East Concession to 143 ft. south Anytime"

and by adding to Section "E" thereof the following items, namely:

"Amelia South Beckett to Kent Anytime

Marisa West Rockview to 62m northerly Anytime

East 21<sup>st</sup> East Concession to 24.6m southerly Anytime"

6. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Amelia Street South North  
Beckett to Westerly End

Julian Avenue West East"  
Roxborough Avenue to Britannia Avenue

and by adding to Section "E" thereof the following items, namely:

"Amelia Street South North  
Kent to Westerly End

Julian Avenue West East"  
Roxborough Avenue to Dunsmore Road

7. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

“Grosvenor	East	commencing at a point 270 feet south of Barton and extending to a point 24 feet southerly therefrom	Anytime
Grosvenor	West	commencing at a point 283 feet south of Barton and extending to a point 16 feet southerly therefrom	Anytime
Ivon	East	from a point 214 feet south of Melvin to a point 19 feet southerly therefrom	Anytime
William	East	from 110.9m south of Birge to 7.3m southerly	Anytime
William	West	from 116.3m south of Birge to 6m southerly	Anytime”

and by adding to Section “E” thereof the following items, namely:

“Belmont	East	from 58.9m north of Cannon to 6.2m northerly	Anytime
Clyde	West	from 28m south of Wright Avenue to 4.6m southerly	Anytime
East 22 <sup>nd</sup>	West	from 124.7m north of Crockett to 5.5m northely	Anytime”

8. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section “E” thereof the following item, namely:

“Concession North		from 169ft. west of Belwood to 180ft. westerly	Anytime”

and by adding to Section “E” thereof the following item, namely:

“Concession North		from 75m west of Belwood to 30.2m westerly	Anytime”
-------------------	--	--	----------

and by adding to Section “F” thereof the following items, namely:

“Peachwood South & Crescent	West	from 37.5m east of the northern intersection with Titan Drive to 39.2m easterly and southerly along the curbline	Anytime
-----------------------------	------	--	---------

Peachwood Crescent	South & East	from 46.8m west of the northern intersection with Titan Drive to 29.3m westerly and southerly along the curbline	Anytime
Titan Drive	North & West	from 43.3m west of the southern intersection with Peachwood Crescent to 32m westerly and northerly along the curbline	Anytime"

9. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


"Parkview West 19 feet 59 feet north of Franklin 8:00 a.m. to 10:00p.m

West 19th West from 7m south of Bendamere to 6.4m southerly 8:00 a.m. to 9:00 p.m." Monday to Friday

10. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
11. Sections 3 through 9 of this By-law shall come into force and take effect on the date of its passing and enactment.
