CITY OF HAMILTON

BY-LAW NO. 06-049

To amend City of Hamilton By-law No. 01-084 being a By-law to Appoint Municipal Law Enforcement Officers

WHEREAS Section 11(1) of the Municipal Act, 2001 S.O. 2001, c.25, as amended, authorizes the Council of any single tier municipality to pass by-laws respecting matters within its spheres of jurisdiction;

AND WHEREAS Section 15(1) of the Police Services Act R.S.O. 1990, c.P.15, as amended, authorizes the Council of any municipality to appoint one or more Municipal Law Enforcement Officers, who shall be peace officers for the purposes of enforcing the by-laws of the municipality;

AND WHEREAS the Council of the City of Hamilton, on the 15th day of May, 2001, did pass and enact By-law No. 01-084, being a by-law to appoint Municipal Law Enforcement Officers for the City of Hamilton;

AND WHEREAS it is necessary to amend By-law No. 01-084.

NOW THEREFORE, the Council of the City of Hamilton enacts as follows.

- 1, By-law No. 01-084, as amended, is hereby further amended by adding to Schedule "A" thereof the following names:


