CITY OF HAMILTON

BY-LAW NO. 06-082

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Davidson	East	From 81.7m north of MacDougall to 12.4m northerly	Anytime"
-----------	------	--	----------

and by deleting from Section "E" thereof the following item, namely:

"Forest	South	James to 50 ft. east	Anytime"
---------	-------	----------------------	----------

and by deleting from Section "F" thereof the following items, namely:

"Sunvale Place	West & South	From Waterford Crescent to Cove Crescent	Anytime
----------------	-----------------	---	---------

Sunvale Place	North & East	From a point 59m west of Waterford Cres to a point 20m north of the south leg of Sunvale Place	Anytime"
---------------	-----------------	---	----------

and by adding to Section "F" thereof the following items, namely:

"Sunvale	North & East	From 59m west of the southern intersection with Waterford to the northern intersection with Waterford	Anytime
Sunvale	South & West	From southern intersection of Waterford to 134.8m westerly	Anytime
Sunvale	South	Cove to the southern intersection with Waterford	Anytime"

and by adding to Section "G" thereof the following item, namely:

"Forest	South	James to 15m easterly	Anytime"
---------	-------	-----------------------	----------

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Grosvenor	East	from 22.6m north of Cannon to 5.5m northerly	Anytime
Hughson	Both	Murray to the northerly end of Hughson	Anytime
McAnulty	North	from a point 95 feet east of Benson to a point 23 feet easterly therefrom	Anytime
William	West	commencing 28 feet south of Birge and extending 18 feet southerly therefrom	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Fairview	West	From 36.3m south of Highland to 5.6m southerly	Anytime
Hughson	East	Murray to the northerly end of Hughson	Anytime"

3. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Tuxedo West from 75.5m north of Dunsmure 8:00 a.m. to 6:00 p.m."
to 4.3m northerly

and by adding to Section "E" thereof the following item, namely:

"Grosvenor East From 22.6m north of Cannon Anytime"
to 5.5m northerly

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
