**CITY OF HAMILTON  
BY-LAW NO. 06-117  
To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" thereof the following items, namely:

Galley Rd./Norma Cres.	Northbound & Southbound	Meadowbrook Dr.
Speers Rd.	Eastbound	Meadowbrook Dr.

Norma Cres.	Southbound	Abbey Cl.
Abbey Cl.	Westbound	Meadowbrook Dr.

and by adding to Section "B" thereof the following items, namely:

and by deleting from Section "E" thereof the following item, namely:

"Springvalley	Westbound	Winterberry"


