CITY OF HAMILTON

BY-LAW NO. 06-122

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. By-law No.01-218, as amended, is hereby further amended by deleting from paragraph 8(5)(a) thereof the word "that", immediately following the phrase, "for a period of time greater" and substituting in its place the word "than".
2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Cross	West	From 29.2m south of Park to 13.3m southerly	Anytime"

and by deleting from Section "G" thereof the following item, namely:

"West	West	From 24.4m north of Young to 24.7m northerly	8:00 a.m. to 4:00 p.m." Monday to Friday

and by adding to Section "G" thereof the following items, namely:

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

"King	North	From 65.2m east of Sydenham to 8.7m easterly	Anytime
West	West	From 34.8m north of Young to 14.1m northerly	8:00 a.m. to 4:00 p.m." Monday to Friday

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Cope	East	From 17.7m south of the extended south curb line of Hope to 6.7m southerly	Anytime
Cope	East	from 17.7m south of the extended south curb line of Hope to 6.7m southerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Cheever	East	From 70.1m north of Barton to 6.4m northerly	Anytime
Cheever	West	From 63.1m north of Barton to 7.9m northerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Hatt	South	Creekside to 20.2m westerly	Anytime"

and by deleting from Section "E" thereof the following item, namely:

"Stirton	West	Barton to 100 ft. southerly	Anytime"


5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

"Huron	North	From 42.5m west of Minto to 6.7m westerly	8:00 a.m. to 6:00 p.m.
Merchison	South	From 18.4m west of Harmony to 6m westerly	8:00 a.m. to 6:00 p.m."

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
