**CITY OF HAMILTON  
BY-LAW NO. 06- 141**

**To Amend By-law No. 01-218, as amended,  
Being a By-law To Regulate On-Street Parking**

**HEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following items, namely:

"Morwick	South	From 33.2m east of Valridge to 10.4m easterly	Anytime
----------	-------	--	---------

Valridge	West	From 21.5m south of Morwick to 10.2m southerly	Anytime"
----------	------	---	----------

and by adding to Section "E" thereof the following item, namely:

"Walter	Both	From 39m north of Queenston to Main	8:30 a.m. to 6:00 p.m." Monday to Friday
---------	------	--	---

and by deleting from Section "F" thereof the following item, namely:

"Donn Avenue	Both	From Highway 8 to a point 100m south	Anytime"
--------------	------	---	----------

and by adding to Section "F" thereof the following items, namely:

"Donn	East	Queenston to 100m southerly	Anytime
-------	------	-----------------------------	---------

Donn	West	Queenston to 152.5m southerly	Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Avondale	East	commencing 144 feet north of Beechwood and extending 18 feet northerly therefrom	Anytime
-----------	------	--	---------

Avondale	West	commencing 156 feet north of Beechwood and extending 16 feet northerly therefrom	Anytime
----------	------	--	---------

Cheever	East	from 107.9m south of the northern intersection with Birge to 5.2m southerly	Anytime
---------	------	---	---------

Cheever	West	from 72.7m south of the southern intersection with Birge to 6.6m southerly	Anytime"
---------	------	--	----------

and by adding to Section "E" thereof the following items, namely:

"Beechwood	North	From 9.8m east of Gage to 6.2m easterly	Anytime
------------	-------	---	---------

Beechwood	South	From 10.3m east of Gage to 7m easterly	Anytime
-----------	-------	--	---------


Clinton	North	From 45.9m west of Ruth to 5.6m westerly	Anytime"
---------	-------	--	----------

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

4. This By-law shall come into force and take effect on the date of its passing and enactment.
