**CITY OF HAMILTON**

**BY-LAW NO. 06-233**

**To Amend Stoney Creek Business Improvement Area  
By-law No. 612-78, as amended**

**WHEREAS** on the 29<sup>th</sup> day of August, 1978, the Council of The Corporation of the Town of Stoney Creek passed and enacted By-law No. 612-78, known and referred to as "The Stoney Creek Business Improvement Area By-law" in accordance with Section 361(1) of the *Municipal Act*, R.S.O. 1970, Chapter 284, as amended;

**AND WHEREAS** in 1984 The Corporation of the Town of Stoney Creek was incorporated into the City of Stoney Creek;

**AND WHEREAS** pursuant to the *City of Hamilton Act, 1999*, S.O. 1999, c. 14, Schedule "C", the City of Stoney Creek was dissolved on January 1, 2001 and the City of Hamilton stands in the place of the City of Stoney Creek for all purposes.

**AND WHEREAS** pursuant to the *City of Hamilton Act, 1999*, S.O. 1999, c. 14, Schedule "C", every by-law of an old municipality, such as the former City of Stoney Creek, that is in force on December 31, 2000 shall be deemed to be a by-law of the City of Hamilton until it expires or is repealed or amended to provide otherwise.

**AND WHEREAS** pursuant to Section 209 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, a municipality may alter the boundaries of an improvement area;

**AND WHEREAS** on the 1st day of March, 2006, the Council of the City of Hamilton did approve of Item 21 of Report 06-003 of the Planning & Economic Development Committee and did authorize the expansion of the boundaries of the Stoney Creek Business Improvement Area.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. That Schedule "A" to By-law No. 612-78, as amended, be repealed;

2. That Schedule "B" to By-law No. 612-78, as amended, be repealed;
3. That Schedule "A" attached to this by-law be affixed to By-law 612-78 as Schedule "A" thereto;
4. That in all other respects, the contents of By-law 612-78, as amended, are hereby confirmed as unchanged.
