## **CITY OF HAMILTON**

### **BY-LAW NO. 07-184**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Proctor	West	114 ft. north of Dunsmure to 43 ft. northerly	Anytime"
----------	------	--	----------

and by adding to Section "E" thereof the following items, namely:

"Holton	East	King to Wilson	Anytime
Queen	East	Duke to 46.5m northerly	Anytime"

2. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Holton Avenue North	King Street East to Wilson Street	East	West"

3. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


"Bayfield	West	19 feet	231 feet north of McAnulty	8:00 am - 6:00 pm
John	West	from 33.3m north of Burlington to 6.8m northerly		Anytime"

4. Schedule 19 (Airport Bus and Limousine Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Hunter	North	from 16.3m east of Hughson to 8.2m easterly	Anytime"
---------	-------	--	----------

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
