CITY OF HAMILTON

BY-LAW NO. 07-227

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "C" thereof the following item, namely:

"Bayview Ave. All All of cul-de-sac Anytime"

and by adding to Section "G" thereof the following item, namely:

"Weir West from 22.7m south of Barton to 9.4m southerly Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Picton North commencing 138 feet west of James and extending 21 feet westerly therefrom Anytime

Roxborough North From 13.2m west of Tragina to 5.7m westerly Anytime

To Amend By-law No. 01-218, as amended,
Being a By-law to Regulate On-Street Parking

Roxborough	South	From 14m west of Tragina to 6m westerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Birch	East	from 8.1m north of the extended north curb line of Harvey to 8.4m northerly	Anytime

Grosvenor	East	from 28.1m north of Cannon to 5.1m northerly	Anytime"

3. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:


"Rolston	West	120 feet commencing at a point 879 feet south of Miami	7:00 a.m. - 6:00 p.m. " Monday to Saturday

and by adding to Section "E" thereof the following item, namely:

"Rolston	West	from 118.4m west of Sarasota to 22.2m northerly	7:00 a.m. to 6:00 p.m." Monday to Saturday

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
5. This By-law shall come into force and take effect on the date of its passing and enactment.
