CITY OF HAMILTON

BY-LAW NO. 08-037

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Parking Meters) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"MacNab	East	Cannon to Vine	2 hr	\$1.00
MacNab	East	Vine to York	1 hr	\$1.00
MacNab	West	Cannon to York	2 hr	\$1.00
Park	East	York to Vine	2 hr	\$1.00
Park	West	York to Vine	1 hr	\$1.00"

and by adding to Section "E" thereof the following items, namely:

"MacNab	Both	Cannon to York	2 hr	\$1.00
Park	Both	York to Vine	2 hr	\$1.00"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Province East Roxborough to 100 ft. northerly Anytime"

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Province Street from 29.5m north of Main Street East West"
North to Cannon Street

and by adding to Section "E" thereof the following item, namely:

"Province from 29.5m north of Main to East West"
Roxborough

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"East East from 25.2m north of Robert to 5.8m Anytime
northerly

MacNab East from 33.2m north of Strachan to 6m Anytime
northerly

Primrose South from 10.3m east of the extended east Anytime
curb line of Cavell to 5.9m easterly

Primrose North from 7m east of Cavell to 5.8m Anytime
easterly

Stirton West from 33m north of Cannon to 5.7m Anytime"
northerly

and by adding to Section "E" thereof the following items, namely:

"Erindale	East	from 35m south of Montrose to Dundonald	7:00 a.m. to 5:00 p.m. Monday to Friday
Longwood	East	from 90.1m south of King to Main	Anytime
Province	East	Cannon to Roxborough	Anytime"

and by adding to Section "F" thereof the following item, namely:

"Glover	East	from 73.3m south of Highway 8 to 150m southerly	7:00 a.m. to 5:00 p.m." Monday to Friday

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Erindale	East	30 feet	110 feet north of Dundonald	7:00 am – 6:00 pm Monday to Friday
Gibson	East	6.7m	88.7m north of Barton	Anytime
Normanhurst	West	28 feet	307 feet north of Dunsmure	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Erindale	East	from 33.5m north of Dundonald to 9.1m northerly	7:00 a.m. to 5:00 p.m. Monday to Friday


7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Erindale East from 33.5m north of Dundonald to 9.1m northerly 7:00 a.m. to 5:00 p.m.”
Monday to Friday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

9. This By-law shall come into force and take effect on the date of its passing and enactment.
