**CITY OF HAMILTON**

**BY-LAW NO. 08-083**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 5 (Stop Signs) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Winegarden Trail	Westbound	Newcombe Road"

and by adding to Section "C" thereof the following items, namely

and by adding to Section "D" thereof the following items, namely



and by adding to Section "E" thereof the following items, namely

Baffin Way	Northbound	Desoto Drive
Newport Crescent E/Leg	Southbound	Sirente Drive
Newport Crescent W/Leg	Southbound	Sirente Drive

Merrilee Crescent	Westbound	Newport Crescent
Copperhill Court	Northbound	Westridge Drive
Westridge Drive	Eastbound	Upper Horning Rd

2. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
3. This By-law shall come into force and take effect on the date of its passing and enactment.
