BY-LAW NO. 08-125

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Connaught	West	King to 28.4m northerly	1 hr	Anytime	Anyday
Hollywood	Both	Sanders to Main	1 hr	8 am – 6 pm	Mon – Fri
Hollywood	Both	Main to Glenmount	3 hr	8 am – 6 pm	Mon – Fri

and by adding to Section "E" thereof the following items, namely:

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "D" thereof the following item, namely:

"Wills North from 28.7m east of Wilburn to 7m easterly Anytime"

and by deleting from Section "E" thereof the following item, namely:

"Birge North commencing 155 feet east of Emerald and extending 52 feet easterly therefrom 8 am – 12 noon Tues

and by adding to Section "E" thereof the following item, namely:

"Weir East Barton to Britannia Anytime"

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Weir Street Britannia Avenue to Barton Street East West"

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"East West from 70m north of Barton to 6m northerly Anytime

Gibson West commencing 156 feet north of Cannon and extending 23 feet northerly therefrom Anytime

Gibson East commencing 141 feet north of Cannon and extending 21 feet northerly therefrom Anytime

Grenfell South commencing 102 feet west of Stapleton and extending 20 feet westerly therefrom Anytime

"Patrick	South	Easterly end to 35 ft. westerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Hill	North	Dundurn to 32m easterly	Anytime
Parkdale	West	Coronation to 23.8m northerly	Anytime"

6. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Albemarle	West	from 53.8m south of Beach to 7.3m southerly	7:00 a.m. to 6:00 p.m. Monday to Friday
Balsam	West	From 19m south of Maplewood to 6m southerly	8:00 a.m. to 6:00 p.m.
Smith	West	24 feet 435 feet south of Barton	8:30 a.m. - 10:00 a.m."

and by adding to Section "E" thereof the following items, namely:

"Albemarle	West	from 53.8m south of Beach to 7.3m southerly	Anytime
East 7 th	East	from 15.8m north of Fennell to 6m northerly	Anytime
Fairfield	West	from 74.7m south of Vansitmart to 6m southerly	Anytime"



7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Ottawa West From 40m north of Main to 54m northerly 7:00 a.m. to 4:00 p.m."
Monday to Friday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
