

Since the candidate omitted opening a bank account during the election period (an error that she overlooked assuming that since she was the only donor, it would not be necessary), a non profit bank account was opened in December of 2019 at CIBC depositing the total amount of dollars spent, and then withdrawing them and closing the account a few days later.
