## **CITY OF HAMILTON**

### **BY-LAW NO. 08-201**

#### **To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking**

**WHEREAS** Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

**AND WHEREAS** it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Through Highways) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Vansitmart	easterly limit of Kenilworth Avnue	westerly limit of Strathearne" Avenue, except at the intersections of Cope Street and Fairfield Avenue

and by adding to Section "E" thereof the following items, namely:

"Burton	North	From 41.7m east of Victoria to 6.8m easterly	Anytime

9. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:


"Albemarle	West	from 9.1m south of Beach to 8.2m southerly	7:00 a.m. to 7:00 p.m. Monday to Friday
Bowen	East	from 50.4m south of Main to 11.2m southerly	Anytime"
