**CITY OF HAMILTON**

**BY-LAW NO. 09-033**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"High Street	Fennell Avenue East	Woodside Drive	40
Princeton Drive	Fennell Avenue East	Donlea Drive	40
Donlea Drive	Princeton Drive	Oakcrest Drive	40
Oakcrest Drive	Donlea Drive	Mountain Brow Boulevard	40
Woodside Drive	Oakest Drive	High Street	40
Currie Street	Mohawk Road East	Larch Street	40
Palmer Road	Mohawk Road East	Behan Street	40
Reno Avenue	Currie Street	Palmer Road	40"

and by adding to Section "G" (Former Regional Roads) thereof the following item, namely:

"Fifty Rd.                      600 m. south of Hwy 8                      North Service Road                      60"

and by deleting thereof the following items, namely:

"450                      Fifty Road                      Q.E.W.                      600 m. south of Highway #8                      60

450                      Fifty Road                      600 m. south of Highway # 8                      Ridge Road                      50"

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

"Charlton                      125 ft. east of Queen and Queen                      2<sup>nd</sup> lane from north curb                      Anytime                      Westerly to Southerly"

and by deleting therefrom the following item, namely:

"Charlton                      125 ft. east of Queen and Queen                      2<sup>nd</sup> lane from north curb                      Anytime                      Westerly and Westerly to Southerly"


3. Schedule 6 (One Way Streets) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "E" (Hamilton) thereof the following item, namely:

"Hillyard                      Northerly                      Land                      Ship                      (06-148)"

4. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

5. This By-law shall come into force and take effect on the date of its passing and enactment.
